If you do not agree to these Terms and Conditions of Use, please do not download or use the databases. AgBase reserves the right, at its discretion, to change, modify, add, or remove portions of this license at any time.

**AGBASE DATABASES**

"AGBASE DATABASES" refers to a curated resource supporting modeling of functional genomics data that are posted on the University of Arizona website at the URL <http://agbase.arizona.edu/>. AgBase data contains information summarized from published research literature by AgBase staff and predicted computationally, as well as data and other information provided by third parties and integrated in AgBase data sets.

The above AGBASE DATABASES are owned by University of Arizona and its Licensors. Subject to these Terms and Conditions of Use, you may use, modify and redistribute the AGBASE DATABASES on a royalty-free basis, worldwide, and for any purpose; provided that:

- If you modify any AGBASE DATABASES, each modified copy must clearly and prominently:
  - Identify the AGBASE DATABASES from which it was derived;
  - Include all applicable copyright notices and author lists from the AGBASE DATABASES from which it was derived; and
  - Identify or summarize all modifications that were made.
- If you distribute any BIOCYC DATABASES, whether in their original form, in a modified form, or embedded in a product you create, you must:
